# Minute Managing Committee Meeting 20/01/2025

Albert Hakobyan asks if we have to consider also the Athletes Commission.

According to Robert Wota we don't need to foresee an Athletes Commission as we organize activities for athletes Juvenile, Junior I and Junior II.

MC decided as follow:

MC Approve the Provisional Commissions.

MC confirm that three to five must be the members of every commission (also four are accepted). In case of tight chair decides.

## 1.2 Approval of Nominations for DSE Provisional Commissions

Luigi Bodini presents to the Managing Committee the thirteen nominations he received from Federations member. He suggests that, based on each candidate's qualifications, they be assigned to the commissions where they can contribute most effectively to DSE's objectives.

Pietro Braga raises a concern, noting that he does not personally know all the candidates, and emphasizes the importance of CVs for commission chairs to assess their qualifications. He points out that not all CVs have been provided, and suggests considering the nominations as provisional for at least one month, allowing time for discussions with the candidates about the commissions' goals. This would ensure that candidates fully understand their role and can serve DSE to the best of their abilities.

Valdis Skutans agrees with Pietro Braga and proposes extending the evaluation period to two months, as one month may not be sufficient. He also highlights that Turkey has nominated four candidates, while Hungary and Croatia have nominated three. He questions whether such a concentration of nominations from a single country should be reconsidered.

Albert Hakobyan concurs with Valdis, expressing concerns about the potential overrepresentation of candidates from one country.

Luigi Bodini responds by clarifying that the thirteen nominations were received from various member bodies, and emphasizes the importance of involving people who are committed to DSE's projects. He suggests that, moving forward, the goal should be to limit nominations to no more than one person per member body. He stresses, however, that the primary focus should remain on evaluating candidates' ethics and transparency.

Pietro Braga underscores the significance of assessing candidates not only for their skills but also for their ethical standards, to prevent any risk of improper disclosure of confidential information.

Robert Wota emphasizes the need for fairness, suggesting that all DSE member bodies should be treated equally, allowing each body the opportunity to participate if they wish.

Pietro Braga proposes implementing a questionnaire for nominated candidates to gauge their motivation and willingness to contribute to commission projects. He also reiterates that limiting nominations to one candidate per member body could help ensure broader representation.

After analysis and discussion of the nominations, the council decides as follows:

### **Sport Commission**

Approve DSE CGP applications from the initial request till the completed process. Verifies compliance of applications with the rules both before and after the competition.
